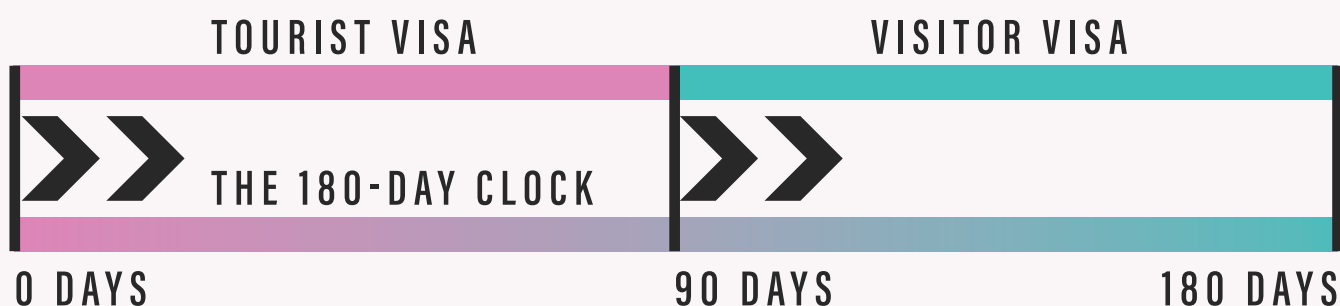
# TOURIST VISA OR VISITOR VISA?

We know you dream of a long stay in France. But do you know the crucial difference between a tourist visa and a Visitor visa? The key lies in the duration and how you plan your adventure. Avoid surprises and discover your path!

THE GOLDEN RULE FOR SHORT STAYS

## THE 90/180 DAYS

If you intend to visit France (and the Schengen Area) for tourism, business, or family visits, the Tourist Visa (Schengen) allows you a maximum stay of 90 days within any 180-day period. This means that every day you spend in the Schengen area counts towards those 90 days, and the 180-day clock is constantly rolling.


# THE VISITOR VISA IS YOUR SOLUTION

If your dream is to live a deeper cultural immersion, study a language, volunteer, or simply enjoy France for more than 90 days, then the Visitor Visa is your ally. This long-stay visa allows you to extend your stay beyond the Schengen limit, offering you the freedom to live and experience France at your own pace.

# WHO IS ELIGIBLE?

This visa is ideal for people in the following situations:

- Anyone wishing to spend time in France and can justify enough financial resources.
- Retirees wishing to reside in France.
- In certain cases, family members of a non-European already residing in France.

# CONDITIONS

- Not to engage in any professional activity in France (for example: income should not come from a French company).
- Being able to justify enough financial resources for the entire duration of the stay without working in France (minimum €1900/month, approximately).
- Subscribing to a private insurance covering the entire stay in France.
- Having accommodation for the entire duration of the stay.
- Having a passport valid for at least 12 months after the planned departure date.

# ADVANTAGES OF THIS VISA

- 01.** ALLOWS YOU TO STAY IN FRANCE FOR MORE THAN 3 MONTHS.
- 02.** GENERALLY ISSUED FOR A DURATION OF 12 MONTHS.
- 03.** RENEWABLE DIRECTLY IN FRANCE.
- 04.** ALLOWS YOU TO SPEND UP TO 90 DAYS IN ANOTHER SCHENGEN AREA COUNTRY AS A TOURIST
- 05.** CAN BE CHANGED TO ANOTHER STATUS (WORK, ENTREPRENEUR, ETC.).



# PROCESSING TIME

Depending on the responsiveness of the applicant and the availabilities of the French authorities, it takes an average of 2 to 3 months from the start of the application process to arrival in France.
